

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **March 28, 2019** at the Payne County Administration Building, Gloria Hesser Commissioner Meeting Room 200, located in Stillwater, Oklahoma.

Chairman Reding called the meeting to order: 9:00 a.m.

The following members were present:

Chairman - Chris Reding, District 2, Vice-Chairman- Zach Cavett, Commissioner District 1, Rocky Blasier – Commissioner District 3, Tammy Mathis – Deputy County Clerk. Invocation by Chris Reding, and Flag Salute to our country by Dewey Clapp.

Approve minutes of the previous meeting of the board:

Clerk's office presented minutes of the March 18th meeting for approval. Motion to approve minutes by Cavett with correction, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Miscellaneous items from the audience:

Lyle Testerman and Donovan Bowers presented concerns to Cavett regarding Sage Rd, and the two (2) cul-de-sacs going off of Sage Rd. in Cushing with drainage issues. Testerman stated about a years ago they had inquired with Cavett regarding his plans for this area. Testerman recalls Cavett stating it would possibly be 2020 before anything could be started. Sage Rd. now has large pot holes, and he feels as though the last time that road was chip and sealed was in the mid 1990's. Testerman also had concerns with Equine and Rolling Hills Rd. which are now down to one (1) lane roads stating they had spoken to a previous Commissioner Deering at that time nearly twenty (20) years ago regarding those roads. Bowers gave Cavett photos showing their concerns and reiterated the same concerns as Testerman regarding drainage issues. Testerman also inquired with the board to see if they would be willing to take inventory of any abandoned pipelines in Payne County. Testerman stated that a lot of those pipelines are sealed and coated with an asbestos material so there was concern for the environment. Testerman stated that he knew of at least six (6) abandoned pipelines near his farm in Cushing that were in the bar ditches. Cavett agreed to meet with homeowners on Monday afternoon to discuss their concerns and pending funding was still hopeful to start something in 2020.

Annual Fair Housing Act Proclamation:

Reding presented the annual fair housing act proclamation that the board signs each year and posts in the Courthouse and Administration building which they are required to do. Reding requested permission to sign the Proclamation and the Chairman sign on behalf of the board. Motion by Cavett for the Chairman to sign the Proclamation on behalf of the Board, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Presentation by Sheriff Department regarding Credit Card Use and Change of Account Holder:

Kevin Woodward, Undersheriff presented changes to the Sheriffs credit card account that are required by statue. The Sheriffs department is requesting the name on the credit card be changed from Payne County Sheriff to Payne County, no more than four (4) cards ordered, the credit limit be changed from \$15,000 to \$10,000, and two (2) county clerk staff will be added to the account for the purpose of conducting business where the billing is concerned. Those two (2) staff members will be Glenna Craig, County Clerk, and Kyla McCombs, Purchasing Agent. Woodward stated that Carl Hiner had created this account back in 2003 and minutes could not be located discussing this account, so they are unsure of how everything was originally setup. Motion by Cavett to approve the name change from Payne County Sheriff to Payne County, change credit card limit from \$15,000 to \$10,000, adding Glenna Craig, and Kyla McCombs as authorized persons to discuss billing changes and the ordering of (4) new cards with changes as presented, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Reding stated the Attorney General Mike Hunter received a settlement from the primary pharmaceutical company and it appears that all of the other suits are going to be settled in that same direction. Reding stated it seems it is already determined where they will be sending the settlement, and it will not be to the counties but probably going to OSU/Tulsa for development of programs. Reding thinks they are going with a law firm to proceed with hope of that funding coming to the county. Cavett felt if we could get those firms that were interested in getting the county signed up to attend one of the meetings then the Board could make a decision and move forward.
