#### **Monthly Reports of Officers:**

None presented on this date.

Public Announcements from the Board: Cavett wanted to remind the public that the county is presenting the renewal of the 1/4th cent sales tax that will be on the ballot for February 11th. The county is requesting to re-purpose the tax for roads and bridges. The tax is currently going toward the jail. This tax will begin March 2021 after the maturity of the bonds for the jail have been paid off. The re-purposed tax will be used for materials, and professional services. This will be split between the two road districts. This was a recommendation of the Payne County Sales Tax Committee. Cavett showed a brochure that is available to the public to give information on the re-purpose of the tax, and a map of the roads that District 1, and 3 plans to improve with the tax if approved. Cavett stated with this tax it will allow the districts to purchase more gravel, dirt, and equipment with the 3/8th cent sales tax. Cavett stated what improvements can be made with this new re-purposed tax. Cavett asked that if there are any questions call your County Commissioners. Reding also stated this is not a new tax, or additional tax, just a continuation of the current tax just re-purposed for county roads from the floods, normal everyday wear and tear, etc. Cavett stated that this tax brings in close to a guarter of a million each month, and this would be divided between districts 1 and 3 50/50 about 125,000.00 for each district each month. This tax is not taking away from the other entities that get the 3/8tn cent sales tax, and the Sheriff is ok with the re-distribution of the 1/4th tax. Blasier concurred with the other two Commissioners.
