

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **January 30th, 2023**, at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

Chairman Zach Cavett called the meeting to order: Meeting called to order at 9:00 a.m.

<u>The following members were present</u>: Zach Cavett – Commissioner District 1, Chris Reding – Commissioner District 2, Rhonda Markum – Commissioner District 3, Tammy Mathis- Chief Deputy County Clerk. Invocation by Zach Cavett and Flag Salute to our country lead by Dewey Clapp.

<u>Approve minutes of the previous meeting of the board</u>: Motion by Reding to approve the January 17th, 2023, minutes as presented, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Motion by Markum to approve the **January 23rd, 2023**, minutes as presented, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Miscellaneous items from the Audience (no action will be taken)</u>: Sheriff Harper stated that Monday Duncan Street would be closed from 7am-6pm with the Chiller being installed on the Jail. Equipment would be brought in for this so the road would be closed during that process.

<u>Discussion/Possible Action –</u> Discussion and possible action approving and authorizing actions to be taken by the County and its officials as designated by the County Commissioners to receive and allocate monies under the Local Assistance and Tribal Consistency Fund ("LATCF"), comply with the requirements of LATCF, and to take any and all necessary actions including, but not limited to, the execution of agreements, documents, reports, certifications, the submission of compliance reports and supporting documentation, and the collection of data required to make decisions regarding the use of LATCF funds: No action under this item.

<u>Resolution 2023-21 – A RESOLUTION APPROVING, AUTHORIZING, ACCEPTING AND RATIFYING ACTIONS TAKEN OR TO BE TAKEN BY THE COUNTY AND ITS OFFICIALS AS DESIGNATED BY THE COUNTY COMMISSIONERS ARE HEREBY AUTHORIZED TO RECEIVE AND ALLOCATE MONIES UNDER THE LOCAL ASSISTANCE AND TRIBAL CONSISTENCY FUND ("LATCF"), COMPLY WITH THE REQUIREMENTS OF LATCF, AND TO TAKE ANY AND ALL NECESSARY ACTIONS INCLUDING, BUT NOT LIMITED TO, THE EXECUTION OF AGREEMENTS, DOCUMENTS, REPORTS, CERTIFICATIONS, THE SUBMISSION OF COMPLIANCE REPORTS AND SUPPORTING DOCUMENTATION, AND THE COLLECTION OF DATA REQUIRED TO MAKE DECISIONS REGARDING THE USE OF LATCF FUNDS; AND DECLARING AN EMERGENCY: Cavett stated that Payne County is eligible to receive \$100,000 in funds which will be two (2) payments of \$50,000, and that the deadline is January 31. Discussion/Possible Action – Acceptance Certificate and Lease Purchase Agreement between Anchor D Bank and Payne County for Purchase of Motor Graders for District #1: Cavett stated this was previously reviewed by former ADA Lowell Barto but he has asked our new legal counsel to review it as well. Motion by Reding to approve the acceptance certificate and lease purchase agreement between Anchor D Bank and Payne County for the purchase of Motor Graders upon the final approval of legal counsel, second by Markum. <u>Discussion/Possible Action – Approval – Lease Purchase Agreement by and between the Board of</u> Commissioners of Payne County, Oklahoma, and B&C Business Products, Inc for one (1) Sharp BP-70C5S Digital Color Copier for the Payne County Treasurer's Office: Cavett stated our legal counsel has already approved the agreement. Motion by Markum to approve the lease purchase agreement with B&C Business Products, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Appointment of Requisitioning and Receiving Officers – Payne County E911 Communications Agency Account: Cavett stated that being Reding was on this board he needed to be placed as a Requisitioning Officer on the E911 Fund as well as Cavett. Motion by Reding to approve changes, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action –</u> Road name requests for Los Rancheros Subdivision – CEDAR RIDGE; BLACKBERRY ST; WELLS AVE; HILLTOP AVE; HIDDEN HILLS; and RAVINE ST; Applicant's Name – Harland Wells, Owner of Record – KW Investments, LLC: Motion by Reding to approve the road name requests as presented with no maintenance by the county and noted that these have also been approved by Crystal Ross in the Assessor's Office, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – Cancellation of Payne County Fair Board Election</u>: Cavett stated that there were no other filings for District 1, 2 or 3 so formal action needed to take place to cancel the Election scheduled for February 6, 2023.
