Public Announcements from the Board (No Action will be taken): Markum stated that last week the Resolution was passed upon her verifying with Shutera and the details of what is done with spraying in regard to the butterflies and bees. Markum stated that she did get with the vendor to confirm the questions that were of concern. Markum stated she did not appreciate that Reding emailed the company Tuesday morning informing them that they could not start the work until his questions were answered. Markum stated she said she would address his concerns with the vendor before they started and did not appreciate Reding over stepping by contacting her vendor and informing them they couldn't start until his questions were answered. Markum stated she does not contact Reding's vendors and tell them what they can or cannot do so she would appreciate and ask that he would return the favor. Reding stated that he did not tell the vendor that they could not start the work. Markum referenced the email she received from the vendor that stated they could not start the work in Payne County until his questions were answered. Reding apologized and stated he would not do that again.

<u>New Business</u>: Lee Denney, Treasurer stated that she attended a class last week on investments and was informed that the county needed a new investment policy.
