The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **November 21, 2022,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

Chairman Chris Reding called the meeting to order: Meeting called to order at 9:00 a.m.

Resolution 2022-72 – Functional Classification Revision Request – ODOT FM-Form 121 – D1: Cavett presented Resolution 2022-72 in regards to changes in major and minor collectors with updating Euchee Rd North of 33, 3 miles and West 1 mile on Fairlawn Rd which is being requested as a major collector. This will allow the funding that is available for the county to be used in funding that project. Motion by Cavett to approve Resolution 2022-72, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

<u>County for Bridge #160 Replacement</u>: Cavett stated this was another bridge that Sac and Fox who have quite a bit of additional federal funding available to tribes. Cavett stated he will have quite a few more bridges coming on soon. Cavett stated this was for professional engineering services contract with EST who already has a good working relationship with Sac and Fox which is essential in smooth working relationships. The total cost for this will be \$83,000 which includes preliminary design, hydraulics, geotechnical investigations, environmental check list, final plans and project letting. Cavett stated this is an 80/20 match with the federal monies where the Tribe will pay 80% and the County 20%. Motion by Cavett to approve the professional contract between EST and Payne County for Bridge #160, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Acknowledge Receipt of Application from Rhyner and Jerri Arthur for Certificate of Authority to Locate or Establish a Cemetery; Set Public Hearing Date; and Authorize Notice of Public Hearing to be Given: Reding presented to the board the request to establish a cemetery on Jerri Arthur's property; the application has been submitted. Barto stated it needed to be on the Commission meeting which has been done, and the notice will need to be published twice in the paper. The hearing has been set for December 12, 2022, at 9am during a regular scheduled meeting. Motion by Cavett to set the public hearing date for December 12, 2022 during the regular commission meeting and authorize notice of publication for public hearing to be given, second by Blasier.
