

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **December 13, 2021,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

Chairman Chris Reding called the meeting to order: Meeting called to order at 9:01 a.m.

Discussion/Possible Action on Bid Openings – 9:30am: Bid 2022-27 thru 41 – 6 month road/bridge construction materials for District 1 and 3: Discussion and possible action on bid openings at 9:30 A.M.: McCombs presented Bid No. 2022-27 thru 2022-41; FY 21-22 for 6 Month bids. Bids are for JANUARY 1, 2022, thru JUNE 30, 2022. Discussion/Possible Action on Evaluations: Bid 2022-26 – Payne County Jail Chiller – Payne County Sheriff: Reese Lane addressed the Board referencing the Facility Authority in his letter for the Jail HVAC Chiller Project. Jackson Mechanical submitted a bid of \$225,784 for replacing the jail chillers. B & L Heating and Air submitted a bid for \$243,000 to do the job as well. B&L's bid was \$17,216.00 over Jackson Mechanical. The Sheriff's Office believes that B&L is the better choice to do the job because of the following: 1) B&L proposes using a Carrier chiller as opposed to the less familiar Aqua Force brand proposed by Jackson Mechanical. 2) B&L offers a 225 ton unit while Jackson Mechanical offers a 213.9 ton unit. 3) B&L is local, and Jackson Mechanical is out of the county. 4) B&L has already established a tradition of quality service, dependability and honesty serving Payne County Facilities and this office.
