

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **December 29th, 2022,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

Chairman Chris Reding called the meeting to order: Meeting called to order at 9:00 a.m.

<u>Miscellaneous items from the Audience (no action will be taken)</u>: Greg Kolsut addressed the board in regard to L3Harris making a mistake in their response and understand that with the process with Tusa Consulting L3Harris is not being considered regardless of how it measured against other designs that were proposed. The toughest part of this decision is that their error was around the one specification that is unrealistic for the County because it increases the price well beyond what the County has allocated. The consultant's decision not to review our proposal in its entirety does not negate the fact that L3Harris proposed design provides exceptional redundancy and coverage. It's all well within the range of the County's budget. Mr. Kolsut stated that L3Harris believes that the County. We do request that the County keeps in mind that the opportunity to rebid the project with realistic technical requirements and within County budget is always an option especially if terms cannot be agreed with the recommended Vendor at a fair price due to the lack of competition that now will exist. Cavett inquired with Kolsut on what the mistake was that was made. Kolsut stated that the 95% coverage requirement one mile outside of the border of the County. Kolsut stated that their engineering team just overlooked this requirement and because of that Tusa is not considering L3Harris in this bid process.

Laura Austin Thomas wanted to thank retiring ADA Lowell Barto for his service to Payne County.
