RESOLUTION NO. 2019-33

A RESOLUTION AMENDING COUNTY RESOLUTION NO. 2005-30 TO PROVIDE A CHANGE OF PURPOSE FOR THE EXISTING ONE-FOURTH OF ONE PERCENT (1/4 OF 1%) COUNTY SALES TAX LEVIED AND ASSESSED THEREBY; TO PRESCRIBE THE EFFECTIVE DATE AND TERMINATION DATE OF SUCH TAX; AND REQUIRING APPROVAL OF SUCH AMENDMENT BY A MAJORITY OF REGISTERED VOTERS VOTING AT AN ELECTION HELD FOR SUCH PROPOSE AS PROVIDED BY LAW.

BE IT HEREBY RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PAYNE COUNTY, STATE OF OKLAHOMA:

Section 1: Amendment of County Resolution No. 2005-30. That Section 1 of County Resolution No. 2005-30 be and the same is hereby amended to read as follows:


“Section 1. Levy of One-Fourth of One Percent Sales Tax – Effective Date and Duration – Purpose of Revenues. There is hereby levied and assessed a one-fourth of one percent (1/4 of 1%) sales tax upon the gross proceeds or gross receipts derived from all sales or services in Payne County, Oklahoma, taxable under the Oklahoma Sales Tax Code.


The sales tax levied pursuant to this Section shall become and be effective on and after April 1, 2021, subject to approval by a majority of the registered voters of Payne County, Oklahoma, voting on the question thereof in the manner prescribed by law and shall terminate on March 31, 2031.

It is hereby declared to be the purpose of the sales tax levied by this Section to provide revenues to be used for the purpose of purchasing road and bridge materials and road and bridge construction services.”

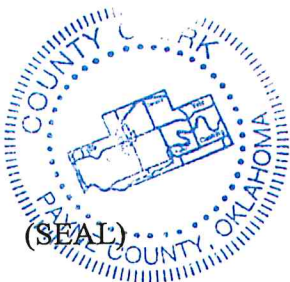
Section 2: That except as amended by this resolution, all other sections and provisions contained in Resolution No. 2005-30 shall continue in full force and effect.



NOTICE OF ELECTION

Under and by virtue of Title 68, Oklahoma Statutes 2001, Section 1370 and the Order of the Board of County Commissioners of Payne County, State of Oklahoma, authorizing the calling of a special election for the purpose hereinafter set forth, as approved by said Board of County Commissioners on the ___ day of November, 2019, I, the undersigned, Chairman of said Board of County Commissioners of said County, hereby call a special election to be held in said County on Tuesday, the 11th day of February, 2020, for the purpose of submitting to the registered, qualified voters of said County the following Proposition:

“SHALL PAYNE COUNTY, OKLAHOMA BE AUTHORIZED TO AMEND COUNTY RESOLUTION NO. 2005-30 LEVYING AND ASSESSING AN EXISTING COUNTY SALES TAX OF ONE-FOURTH OF ONE PERCENT (1/4 OF 1%), PROVIDED THAT THE REVENUES FROM SAID TAX SHALL, COMMENCING ON APRIL 1, 2021, BE USED FOR THE PURPOSE OF PURCHASING ROAD AND BRIDGE MATERIALS AND ROAD AND BRIDGE CONSTRUCTION SERVICES, AND PROVIDING FURTHER THAT THE CURRENTLY PRESCRIBED TERMINATION DATE OF MARCH 31, 2021 FOR SAID EXISTING ONE FOURTH OF ONE PERCENT (1/4 OF 1%) TAX SHALL BE CHANGED AND SAID ONE-FOURTH OF ONE PERCENT (1/4 OF 1%) TAX SHALL TERMINATE ON MARCH 31, 2031?”

The ballot used at said election shall set out the Proposition as above set forth, and shall also contain the words:

- For the above Proposition
Against the above Proposition

Said special election shall be held at the same places and in the same manner prescribed for the conduct of state and county elections and the polls shall be opened at 7:00 o'clock A.M., and remain open continuously until and be closed at 7:00 o'clock P.M.

ORDER

AN ORDER AUTHORIZING THE CALLING AND HOLDING OF A SPECIAL ELECTION IN PAYNE COUNTY, STATE OF OKLAHOMA FOR THE PURPOSE OF SUBMITTING TO THE REGISTERED, QUALIFIED VOTERS OF SAID COUNTY THE QUESTION OF THE AMENDMENT OF THE PRESCRIBED PURPOSE AND TERMINATION DATE OF AN EXISTING ONE-FOURTH OF ONE PERCENT (1/4 OF 1%) COUNTY SALES TAX UPON THE GROSS PROCEEDS OR GROSS RECEIPTS DERIVED FROM ALL SALES TO ANY PERSON TAXABLE UNDER THE OKLAHOMA SALES TAX CODE; AND CONTAINING OTHER PROVISIONS RELATED THERETO.


BE IT ORDERED BY THE BOARD OF COUNTY COMMISSIONERS OF PAYNE COUNTY, STATE OF OKLAHOMA:

Section 1. That the Chairman of said Board of County Commissioners of the County of Logan, State of Oklahoma, be and is hereby authorized and directed to call a special election to be held in said County on Tuesday, the 11th day of February, 2020, for the purpose of submitting to the registered, qualified voters thereof the following proposition:


“SHALL PAYNE COUNTY, OKLAHOMA BE AUTHORIZED TO AMEND COUNTY RESOLUTION NO. 2005-30 LEVYING AND ASSESSING AN EXISTING COUNTY SALES TAX OF ONE-FOURTH OF ONE PERCENT (1/4 OF 1%), PROVIDED THAT THE REVENUES FROM SAID TAX SHALL COMMENCING ON APRIL 1, 2021, BE USED FOR THE PURPOSE OF PURCHASING ROAD AND BRIDGE MATERIALS AND ROAD AND BRIDGE CONSTRUCTION SERVICES, AND PROVIDING FURTHER THAT THE CURRENTLY PRESCRIBED TERMINATION DATE OF MARCH 31, 2021 FOR SAID EXISTING ONE FOURTH OF ONE PERCENT (1/4 OF 1%) TAX SHALL BE CHANGED AND SAID ONE-FOURTH OF ONE PERCENT (1/4 OF 1%) TAX SHALL TERMINATE ON MARCH 31, 2031?”

Section 2. That such call for said election shall be by Notice of Election attached hereto and approved hereby to be signed by the Chairman of the Board of County Commissioners of Payne County, State of Oklahoma, and attested by the Payne County Clerk, setting forth the Propositions to be voted upon and the hours of opening and closing the polls; that the ballots shall set forth the Propositions to be voted upon substantially as set out in Section 1 hereof; and that the returns of said election shall be made to and canvassed by the Payne County Election Board.
