

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **Thursday, February 27th, 2020** at the Payne County Administration Building, Commission office, room 203, located in Stillwater, Oklahoma.

Chairman Reding called the meeting to order:

Meeting called to order at 9:00 a.m.

The following members were present:

Approve minutes of the previous meeting of the board:

The Clerk's office presented minutes from the previous meeting. Motion to approve the minutes of February 18th, 2020 meeting by Cavett, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Discussion and Possible Action on Reports from Officers and Boards:

Discussion/Possible Action - Bids out for three (3) bridges, Circles #007, #088 and #126:

Jeffery Dixon wanted to know if the Commissioners wanted to wait since FEMA is rejecting the bridges. Dixon stated that since FEMA was rejecting these bridges there had been a few items added. Dixon stated those few items that were added were required by FEMA. If FEMA wasn't going to help with funds, then Dixon was inquiring on making those changes by removing them. Cavett stated what documentation he received from FEMA was stating that they were willing to pay for some of the wing walls. Cavett stated he did not have the opportunity to completely go through it. Cavett was checking to see if they went ahead and built it if they would go ahead and pay us for what they thought they should. Cavett inquired with Dixon and asked if the bids documents were written in such a way that we can make changes, Dixon stated no, we can alternate items, or maybe just go out and see what bids we receive. Mathis inquired if they were going to go out to bid as the Clerk's Office was receiving phone calls about bids for bridges after reviewing the agenda. Our office was not aware of bidding, so the Clerk's Office was checking. Cavett stated yes, he was going to move forward with bidding. Dixon stated he would get the information to the Purchasing Agent in the Clerk's Office. Motion by Cavett to approve the bid documents for the three bridges as presented, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Resolution 2020-02 - 3/8th Cent County Sales Tax Road Money Notification Resolution D3:

Blasier stated this resolution is for use of the 3/8th cent county sales tax fund to repair and place in working order (2) road graders, and a dump truck for District 3. Motion by Blasier to approve resolution 2020-02 as presented, second by Cavett. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Reding stated he wanted to also tie in the agenda item below for the request of the Courthouse Lawn for the Remembrance Vigil for May 4th at Noon. Discussion/Possible Action – Proposed Policy – Dogs in the Courthouse:

Reding stated he forwarded the board the email from Barto regarding this topic. A few weeks ago, a young lady came in with a pit bull wearing a very nice dog sweater as a "service dog". Reding had concerns with a pit bull in the Courthouse with a lot of people around doing visitations for the jail that day. This just brought up past concerns regarding untrained or emotional support animals in the courthouse or county property with the concern of someone getting bit, and the liability on the county. Barto has drafted a policy in the past but nothing came of it; Reding stated it fits within Title 7 Oklahoma Statute Section 19.1. Reding stated in speaking with the Sheriff's Office they too have been working on something very similar on the Federal side of it. Reding would like to put something in place similar to what Barto has with a few additions. Reding said his main concern was making sure the animal was trained. The Federal policy states that we can ask if the animal is required because of a disability, and what task or service is the animal trying to perform but cannot ask to see certification. Cavett inquired about the law requiring the county to allow animals and Barto stated the Federal law does this, it comes from the American Disability Act. Barto said the animal must be controlled and trained by the owner. You can only ask them to leave if the animal isn't being controlled. Motion by Cavett to table the policy to allow more time to review, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Discussion/Possible Action – Agreement with Midcon Shredding for Election Board, Assessor and County Clerk's Office:

The Clerk's Office is presenting the following contracts Mathis stated the cost was for \$35 month for the County Clerk's Office, The Assessor's Office, and The Election Board Office.
