

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **March 6th, 2023,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

<u>Chairman Zach Cavett called the meeting to order:</u> Meeting called to order at 9:00 a.m.

Approve minutes of the previous meeting of the board:

<u>Miscellaneous items from the Audience (no action will be taken)</u>: Jason LaForge with L3Harris wanted to echo comments from last week's meeting regarding the committee meetings that occurred without L3 Harris's knowledge but was made aware that the competitor was allowed to attend. LaForge was still waiting on the Open Records request that he requested but has not yet received those to confirm if they did in fact attend. No action taken.

<u>Prevention Month Pinwheel Display Event April 3, 2023, at 11:30am</u>: Motion by Markum to approve the request for the use of the courthouse lawn on April 3, 2023 for Annual Child Abuse Prevention Month, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Payne County, Oklahoma – Solicitation #2323-21 Payne County, OK P25 Radio Network</u>: Reding stated the corrections had been made with the assistance of our ADA Jeremiah Gregory therefore Reding motion to approve the contract as presented. Markum inquired with the board on waiting to sign with what L3Harris has brought before the board. Reding stated that he felt the board has already done the steps with bidding, the use of Tusa Consulting, and felt the entire process was fair. Markum had concerns with moving forward with the price and quantities of radios being ordered. Cavett also had concerns but his understanding is that the discount was offered with this package and if we do not buy the quantity then that discount will decrease as well but ordering less radios should decrease that cost as well.
