Transfers: Craig presented a transfer for \$56,191.40 for the Sheriff's Office from Jail Operations Salary 0001-2-3400-1110 to Social Security 0001-1-2300-1210 for \$10,108.86, Retirement 0001-1-2300-1221 for \$19,741.53 and Health Insurance 0001-1-2300-1222 for \$26,341.01 totaling \$56,191.40 and \$500 from County Clerk Travel to County Clerk M&O. Letter of Commitment: None presented on this date.

Range changes/discussion/possible action: None presented on this date.

Approval of Employee request for Leave and/or Request for leave share: None presented on this date. Discussion/Possible Action – Premier Consulting Claims Update, Fees for Service: Dana Neighbors and Amber Martin from Premier Consulting presented to the board what their cost was associated with our premiums as well as a brief update on claims filed from 2019 and 2020. Craig stated that when Premier attends the Budget Board meeting to present premiums at another scheduled budget board later on in the year they will also break up and include Premier's cost separate from the premium costs for the Board. No action taken.

Discussion/Possible Action – American Fidelity IRS Changes: Robert Swain with American Fidelity went over IRS changes regarding new laws regarding additional flexibility for health flex accounts and dependent care assistance programs. Deadline to make a decision for Payne County is April 15th. No action taken but will be placed on the next Budget Board Meeting.

<u>COVID19 Update</u>: Reding stated the Fairgrounds was still doing COVID shots if anyone was needing one. **<u>New hires/discussion/possible action</u>**: None presented on this date.

<u>New business/discussion – no action will be taken</u>: Craig inquired on why the item for discussing full time and permanent part time employees that was tabled from the last meeting was not on the agenda for today. Reding stated he was not sure as it was on the agenda but unsure as to why it was taken off. Craig inquired with everyone making sure they had received the email she sent out from OPERS regarding this matter. Manning inquired with Cavett to see if he could wait until the next meeting or if it was time sensitive, Cavett stated he could wait.
