# Discussion/Possible Action – Fair Board Request Concerning County Building formerly used by MPower, Inc.:

Nathan Anderson, OSU Extension Office, and Colin Campbell, Payne Co Expo Center presented to the board regarding the MPower building. Campbell stated the Fairboard has had the opportunity to tour the building during the day since there are no utilities on at the building. The building currently has not had any utilities on for the last few years. The Fairboard would like to have the building inspected with the utilities on as well as having the roof inspected due to the length of time it has been empty. The Fairboard would need to have the building inspected before entering into a lease. Barto stated there is a lease agreement that has been drafted but that is as far as it has gone. Barto stated he had emailed over the draft to Reding about 3-4 weeks ago. Cavett felt the utilities needed to be turned on and appoint someone to handle the business of the building. Barto stated that District 2 would have the authority to turn on the utilities being that Reding is over the buildings for the County. Campbell stated that the Fairboard was willing to help with the inspection costs of up to \$1,200. 00. Anderson expressed some concerns with some standing water in an area which could be due to the amount of rain we had last year.
