Motion by Cowan to accept cash appropriations as presented, second by Craig. Roll Call Vote: Allen-Yes, Craig-Yes, Cavett-Yes, Manning-Yes, Harper-Yes, Blasier-Yes, Reding-Yes, Cowan-Yes.
Transfers: Craig presented a transfer for the District Attorneys Office with an amount of $\$ 3949.00$ to be transferred from the Revolving Drug Forfeiture fund to the Cash Seizure fund. Manning presented house keeping transfers stating back in 2018 when the county went to the new chart of accounts the investments were moved over into another fund separating operating funds from investments. Manning stated those are now being put back together into one fund. The investment funds accounts will be closed out and put back into the operating cash accounts. Manning further stated that they were being called transfers but it was not technically a transfer but it was also not an error correction. Craig stated that they would be placed back into a sub account so that it can still be tracked separately. Motion by Cowan to approve the transfers as presented, second by Allen. Roll Call Vote: Craig-Yes, Cavett-Yes, Manning-Yes, Harper-Yes, BlasierYes, Reding-Yes, Cowan-Yes, Allen-Yes.
Letter of Commitment: None presented on this date.
Range changes/discussion/possible action: Harper stated that he had one range change for the Sheriff's Office with someone stepping down so he will be replaced with someone else, and Colin Campbell with the Fairgrounds would also have one as well going from a 32 to a 35 range. Motion by Cowan to approve the range changes as presented, second by Allen. Roll Call Vote: Cavett-Yes, Manning-Yes, Harper-Yes, Blasier-Yes, Reding-Yes, Cowan-Yes, Allen-Yes, Craig-Yes.
Discussion/Possible Action - Policy Change/Clarification re Full Time and Permanent Part Time Employees: Cavett presented the latest update from Barto on the clarification of full time and permanent part time employees. Cavett handed out the recent updates from Barto stated that he believed Barto had also received the opinions from OPERS and does not believe that it has changed his original opinions. Cavett stated that Barto felt that what has been handed out today meets all applicable laws. Craig provided IRS regulations defining full time employees being any employee that worked 30 hours per week or 130 hours per month as full time. Craig also reminded the board that we have also been given opinions from OPERS and Department of Labor regarding the definitions of full time. Cavett stated that he did not believe that Barto agreed with the OPERS opinion. Craig had serious concerns with disregarding the opinions of OPERS, Department of Labor and IRS. Cavett felt the benefit of being a permanent part time employee with no benefits gives them the freedom to come and go. Craig reiterated that they must stay under 30 hours per week to not be automatically placed as full time. Craig stated also the policy states that the County Election Board Secretary shall be eligible for the following fringe benefits only retirement and health. The Clerk stated that she is receiving longevity, Reding was thinking that had been addressed before but he could not remember. Motion by Craig to correct the current fringe benefit to add longevity for the Election Board Secretary since that is what is happening, second by Cowan. Roll Call Vote: Manning-Yes, Harper-Yes, Blasier-Yes, Reding-Yes, Cowan-Yes, Allen-Yes, Craig-Yes, Cavett-Abstain.

Cavett later stated that if we are going to keep track of hours then he felt the Country Clerk's Office should be tracking the hours of part time employees as HR. The County Clerk said no, that would be the Departments job, Cavett disagreed stating that was HR. Craig stated her office was not HR according to Barto. Cavett inquired on who was HR for Payne County, Craig stated you were HR of your own department our office handles the payroll. Cavett asked then why was my employee changed automatically? Craig advised Cavett to speak with Barto, that her office was doing what they were advised to do from him.
COVID19 Update: None presented on this date.

## Approval of Employee request for Leave and/or Request for leave share:

New hires/discussion/possible action: Harper stated next month he would be hiring someone that has 13 years of experience in law enforcement and would be requesting to bring them in at a higher range due to that experience. Motion by Craig to approve the new hire at a higher range based on experience, second by Cowan. Roll Call Vote: Harper-Yes, Blasier-Yes, Reding-Yes, Cowan-Yes, Allen-Yes, Craig-Yes, Cavett-Yes, Manning-Yes.
New business/discussion - no action will be taken: Craig and Cowan updated the board stating they hoped to be done with the Board of Equalization meetings by the end of June with hopes of not needing to go into any special sessions.
