

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **April 17th, 2023,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

Chairman Zach Cavett called the meeting to order: Meeting called to order at 9:00 a.m.

<u>The following members were present</u>: Zach Cavett – Commissioner District 1, Chris Reding – Commissioner District 2, Rhonda Markum – Commissioner District 3, Leslie Echalk – Deputy County Clerk. Invocation by Chris Reding and Flag Salute to our country lead by Dewey Clapp.

Approve minutes of the previous meeting of the board:

Motion by Reding to approve *April 10th, 2023,* minutes as presented, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Miscellaneous items from the Audience (no action will be taken)</u>: None presented on this date. Discussion/Possible Action on Reports from Officers and Boards:

Resolution 2023-61 – CIRB (County Improvements for Road and Bridges) Priorities and Projects for Payne County, Oklahoma's Transportation Plan: Cavett presented Resolution 2023-61 for CIRB. Motion by Markum to approve priorities and projects for Resolution 2023-61, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – OCCEDB Environmental Enforcement Grant Applications for FY 2023-</u> <u>24 – D1, D2, and D3</u>: Cavett stated this was for Environmental Enforcement which helps to pay for the roll off dumpsters for all three Districts. Motion by Reding to approve the grant application request as presented, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Discussion/Possible Action – Jail Services Agreement Approval by and between the City of Perkins, Oklahoma, and the Board of County Commissioners of Payne County, Oklahoma, and the Sheriff of Payne County, State of Oklahoma: Cavett stated this is a jail service agreement for \$27/per day. Motion by Markum to approve the Jail Service Agreement as presented and the Chair to sign on behalf, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – Plat Approval – Prairies Edge Addition</u>: Aaron Ferguson with Keystone Engineering presented Prairie's Edge Addition to the board. Motion by Reding to approve Prairie's Edge Plat approval, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Motion by Reding to have the Chair and Vice Chair as requisitioning, leaving receiving officers as Shawna Bales and Tammy Mathis but changing the Warrant Pickups to Cavett and Reding as well, second by Markum.
