

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **April 27th, 2023,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

<u>Chairman Zach Cavett called the meeting to order:</u> Meeting called to order at 9:00 a.m.

<u>The following members were present:</u> Zach Cavett – Commissioner District 1, Chris Reding – Commissioner District 2, Rhonda Markum – Commissioner District 3, Tammy Mathis – Chief Deputy County Clerk. Invocation by Rhonda Markum and Flag Salute to our country lead by Dewey Clapp.

Approve minutes of the previous meeting of the board:

Motion by Markum to approve *April 17th, 2023,* minutes as presented, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Miscellaneous items from the Audience (no action will be taken)</u>: Colin Campbell, Expo Center Director inquired with the board on using the MPower parking area for the event this weekend due to all of the rain. Cavett stated that the board could not take action on this.

Discussion/Possible Action on Reports from Officers and Boards:

Resolution 2023-62 – Acceptance of a \$500 donation to the Payne County Sheriff's Office Department from the Stillwater Home Builders Association: Cavett presented Resolution 2023-62 for a donation from the Stillwater Home Builders Association to the Sheriff's Department. Motion by Reding to approve Resolution 2023-62 as presented, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – Approval City Tele Coin Company, Inc., Correctional Communications</u> Services Agreement by between City Tele-Coin Company, Inc., and Payne County Sheriff's Office: Motion by Reding to approve the agreement with City Tele Coin and the Sheriff's Office with the Chairman to sign on behalf of the board, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes. <u>Discussion/Possible Action – GPS for all County Owned Vehicles and/or Equipment</u>: Reding stated that he did receive notification that the units for Emergency Management have been shipped. Reding would like to request that there be GPS trackers placed on all county vehicles for maintenance and what maintenance is being done. Jeremiah Gregory, county attorney, stated that the board cannot enforce this on other departments like the County Assessor. Gregory wanted to make sure that when stating "all" that this would not include other departments. Reding changed his motion to put GPS on all county owned vehicles and equipment that are controlled and maintained by the County Commissioners, second by Markum. Cavett stated that he had concerns about placing trackers on all equipment that is not used all the time and may only be used once or twice a year; he felt this was not great use of the taxpayers' funds. Markum felt the GPS trackers should only be used for semis and graders, not all equipment. Cavett still had concerns of where the funding would come from. Amended motion by Reding to place GPS trackers on all semis, pickups, and graders if the funding is approved by the budget board to use the general fund, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Ingress and Egress Agreements</u>: Markum presented an agreement with Randy Porter at 417 S Lewis, Stillwater, OK. Markum stated this was for clearing fence row, sloping banks, running ditches, and using the dirt to build up the road. Motion by Markum to approve the Ingress and Egress agreement as presented, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.
