

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **Thursday, April 28, 2022,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

<u>Chairman Chris Reding called the meeting to order</u>: Meeting called to order at 9:00 a.m.

<u>Approve minutes of the previous meeting of the board</u>: Motion by Cavett to approve Minutes of April 18th, 2022, as presented, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

<u>Discussion/Possible Action – Approval – Claim Form 324A ODOT for District 1</u>: Cavett presented ODOT form 324A for \$5000 reimbursement from the CIRB funds for the right of way staking on Norfolk Rd from OK 33 to Fairlawn Road. <u>Discussion/Possible Action – Approval – OCCEDB Environmental Enforcement Grant Applications</u> <u>for FY 2022-2023 – District 1, District 2 and District 3</u>: Reding stated each year the Districts request \$5,000 each per District. Cavett stated though the request is \$5,000 there is only \$4500 each available. Motion by Cavett to approve the request as presented, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

<u>Discussion/Possible Action – Motorola – Countywide Radio System</u>: The Board discussed the countywide radio system. The total cost requested from ARPA funds is \$8,850,000 which includes a discount of \$800,000 if this is approved today. After discussion by the board Motion by Reding to set aside 9.6 million of the ARPA funds for the radio system and the post warranty with the remainder of the funds to be used for other purposes, second by Blasier.
