

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **April 29th, 2020** by teleconference Webex meeting **965-912-250**. located in Stillwater, Oklahoma.

Chairman Chris Reding called the meeting to order:
