

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **May 15th, 2023,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

Chairman Zach Cavett called the meeting to order: Meeting called to order at 9:00 a.m.

<u>The following members were present:</u> Zach Cavett – Commissioner District 1, Chris Reding – Commissioner District 2, Rhonda Markum – Commissioner District 3, Leslie Echalk – Deputy County Clerk. Invocation by Chris Reding and Flag Salute to our country lead by Dewey Clapp.

<u>Approve minutes of the previous meeting of the board</u>: Motion by Reding to approve *May 8th, 2023,* minutes as presented, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Miscellaneous items from the Audience (no action will be taken)</u>: Campbell with the Expo Center wanted to let the board know of the annual Stillwater Chamber Ag Committee Businessperson Judging on June 2 at the Expo in the Heritage Hall. Anyone that would like to join can visit the Chambers website to sign up.

Choplin with Emergency Management wanted to inform the board of the amount of rain and damage the county districts may have received. Choplin was requesting any reports from the Commissioners if they had any damages so these can be turned into the state. Choplin stated there was also an oil leak that is being cleaned up.

<u>Discussion/Possible Action on Reports from Officers and Boards</u>:

<u>Discussion/Possible Action – Contract Design Review Customer Billing Milestone One Certification</u> <u>for Motorola Solutions</u>: Cavett stated this contract is stating that they have met and reached that first benchmark to collect 15% of the contract in the amount of \$1,188.777.15 with the Chair to sign on behalf of the board. Motion by Reding to approve the contract and the Chair to sign on behalf of the board, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – Contract Approval – between Payne County Health Department and Gary Lockett, to provide Directly Observed Therapy (DOT) and related services to tuberculosis (TB) patients, FY 2022-2023</u>: Cavett stated this contract is for the current year and the one below is for FY 2023-2024 with the Payne County Health Department. Motion by Reding to approve both contracts with one vote, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Discussion/Possible Action – Contract Approval – between Payne County Health Department and Gary Lockett, to provide Directly Observed Therapy (DOT) and related services to tuberculosis (TB) patients, FY 2023-2024: approved above.

Discussion/Possible Action – Approval of Lease Agreement by and between the Board of Commissioners of Payne County Oklahoma and the Payne County Sheriff's Office for the County Owned Building Previously Housing M Power, Inc: Cavett stated this is a lease agreement that was drafted by our ADA with a 99 year lease at one dollar a year with either party having the option to cancel with a 30 day notice. Should the Board of Commissioners decide to cancel the lease within five (5) years of the contract's start date the Sheriff's Office would be reimbursed any expenditures made on the building for improvements. Motion by Markum to approve the lease agreement, Reding felt that before this could be done the Commissioners would need to take control back from Economic Development before it can be leased. Cavett stated that he too had thought of that and after contacting the County Clerk's office there is no documentation with minutes where that was ever done. Craig, County Clerk stated that there was discussion in minutes where former ADA Barto was going to do a contract, but it was never drafted, Reding stated if that had not been done then he would second., second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Management and the current operations, GPS reports and County District Commissioner assignment of these two agencies: Cavett stated last week he had made a motion for Markum to supervise the Environmental Enforcement department, but it was requested to be tabled. Cavett would make that motion again to have Commissioner Markum be the direct supervisor for Environmental Enforcement, second by Markum. Markum stated she felt that there needed to be better structure and supervision for this department and their office is right next door to District 3. Roll Call Vote: Markum-Yes, Reding-No, Cavett-Yes. Cavett stated after the information regarding the Environmental Enforcement Department Cavett made a motion to appoint District 1 Commissioner over Emergency Management, Reding felt it was a bad decision for District 1 to take over this department and if moved anywhere it should go to the Sheriff's Department. Markum stated that she would second the motion. Markum stated it was her understanding they were still working from home and didn't understand why they were not in their office. Roll Call Vote: Markum-Yes, Reding-No, Cavett-Yes.
