Resolution 2020-17 – Authorization to Place Gate Across Dead End County Road – Twin Mounds Rd for District 1: This bridge has been out for more years than Cavett can recall. Cavett stated that a constituent who has recently purchased some property in this area would like to put up a gate on a deadend county road. People are going down by where a bridge used to be and causing havoc so the gate would allow them to control that traffic. He will still have to permit other homeowners' access to that area.
