

Official Minutes of PAYNE COUNTY Board of Equalization

The Payne County Excise Board met in a Special meeting of the Board in Suite 202, at 11:30 a.m. on **May 9, 2019,** at the Payne County Administration Building located in Stillwater, Oklahoma.

Chairman called the meeting to order:

Approval of minutes of the previous meeting of the board:

Anita Rush, County Assessor's Office presented 2019 Exempt Manufacturing Applications. Rush stated she had the originals that needed to be signed for Asco Manufacturing Exempt with six (6) accounts and Tom Peck out of Cushing has one (1) account. Rush stated they enter what has been sent to the Assessor, then all original paperwork is sent to the State, once the State has either approved or not approved. Rush stated last year the amount that was reimbursed was 1.3 million. Motion by Teague to approve the Exempt Manufacturing Applications so they can be sent on to the State, second by Sasser. Wedel noted the 2019 Real and Personal Valuations, 2019 Homestead Exemptions, 2019 Freeze Double Homestead Applications, 2019 Veterans Exemption were not presented.
