- Floodplain adding \$1000 for travel, \$4000 for M&O for a total of \$5000
- Sheriff's Office dropped \$221,111
- General M & O dropped \$80,000
- Emergency Operations dropped to \$42,200
- Reward Fund adding \$3,000
