<u>Discussion/Possible Action – Approval – Agreement with City of Cushing:</u> Cavett thank Barto for preparing this agreement. Cavett stated this agreement is for the purpose of defining the duties and responsibilities of each being Payne County and City of Cushing in a joint project to repair and improve Little Road and Eseco Road which is all outlined within the agreement. Motion by Cavett to approve the interlocal coop agreement between the Board of Commissioners and City of Cushing, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

Approval – Date and Location Request for 2020 Treasurers Resale: Manning stated she had a little over 60 properties at the time Manning requested the postponement and she is now down to 51. Discussion/Possible Action Approval Jail Services Agreement between Payne County Board of Commissioners and City of Perkins: Reding stated this is an annual agreement between the City of Perkins and the Board of Commissioners. Woodward Sheriff stated that Barto had reviewed the agreement. Motion by Blasier to approve, second by Cavett. Motion by Blasier to approve agreement as presented, second by Cavett. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes. Cavett later noted that this agreement needed to be signed by the Chairman on behalf of the Board. Motion by Cavett to add that this

agreement needed to be signed by the Chairman, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

<u>Discussion/Possible Action – Bridge Load Posting Signs -CEC:</u> Reding stated this is an agreement regarding the posting of signs. His understanding was that if while CEC is out inspecting the bridges if a decal needs to be changed they will just charge for that decal to be changed or if a sign is completely torn down then they will only be billed for material. Cavett felt that this would be a good cost savings for the County. Motion by Cavett to allow CEC to make load posting signs as necessary, second by Blasier. Roll Call Vote: Cavett-Yes, Blasier-Yes, Reding-Yes.

<u>Discussion/Possible Action – Rental Agreement – Warren Cat</u>: Blasier stated this was for the reclaimer and stabilizer. The cost for the Stabilizer and Reclaimer daily is \$2667, weekly \$6928 and thirty days \$18,975. The cost for the Roller is \$750 daily, \$1950 weekly and \$5350 monthly. Blasier stated he was hopeful that him and Cavett would be done in that thirty (30) days.
