

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **July 3rd, 2023**, at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

<u>Chairman Zach Cavett called the meeting to order:</u> Meeting called to order at 9:00 a.m.

<u>The following members were present:</u> Zach Cavett – Commissioner District 1, Chris Reding – Commissioner District 2, Rhonda Markum – Commissioner District 3, Leslie Echalk – Deputy County Clerk. Invocation by Chris Reding and Flag Salute to our country lead by Dewey Clapp.

<u>Approve minutes of the previous meeting of the board</u>: Motion by Reding to approve *June 29th, 2023,* minutes as presented, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Discussion/Possible Action on Evaluations:

- a. Bid 2024-18 Rebid Brush Truck Bed (Perkins Fire) Joe Barta, Perkins Fire Chief informed the board they would like to reject Bid 2024-18. Motion by Markum to reject all bids per the recommendation of the Perkins Fire Chief, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.
- b. Bid 2024-19 Road Striping (District 3) Markum stated her office has located reduced amounts on State Contract therefore she would be rejecting all bids. Motion by Markum to reject Bid 2024-19, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Discussion/Possible Action Project Agreement JP 36561(04) Lake Access Road Project between Oklahoma Department of Transportation and the Board of County Commissioners, Payne County Oklahoma: Cavett stated this agreement with ODOT will reimburse Payne County up to \$850,000 for this project. Reding inquired on this project if it was a new or existing road. Markum stated it was 2 miles of Redlands Road from Highway 51 to Lakeview, then from Redlands on Lakeview into the campgrounds there at the lake with a total of 3 (three) miles of road. Motion by Markum to approve the agreement as presented, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – FY 23-24 Contract for Pest Control Services at the Payne County Health Departments between Peak Pest Services and the Board of County Commissioners, Payne County Oklahoma:</u> Motion by Reding to approve item B & C contracts together for Pest Control Services and Oklahoma State University both with the Payne County Health Department, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action FY 23-24 Contract to Provide Graduate Research Assistant and Clinical Supervisor to the Payne County Health Department Between Oklahoma State University and the Board of County Commissioners, Payne County Oklahoma:</u> Item approved with item A.

Resolution 2023-81 – 2023 – 2024 ACCO SIG Property and Liability Insurance Renewal/Option Selection: Cavett stated he was able to get an updated premium quote for the additional 10 million that needed to be insured increasing the original amount by approximately \$50,000. Cavett stated this averaged out to .32 cents per 1000. Motion by Reding to approve the updated premium and choose Option 1 payment of \$505,591, second by Markum. Cavett noted this was Resolution 2023-81. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.
