

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **August 21st, 2023**, at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

<u>Chairman Zach Cavett called the meeting to order</u>: Meeting called to order at 9:00 a.m.

<u>The following members were present:</u> Zach Cavett – Commissioner District 1, Rhonda Markum – Commissioner District 3, Chris Reding- Commissioner District 2, Tammy Mathis – Chief Deputy County Clerk. Invocation by Zach Cavett and Flag Salute to our country lead by Dewey Clapp.

<u>Approve minutes of the previous meeting of the board</u>: Motion by Reding to table *August 14th, 2023,* minutes until corrections are made, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes

Miscellaneous items from the Audience (no action will be taken): None presented on this date.

<u>Discussion/Possible Action on Bid Openings – 9:30 AM</u>: None presented on this date.

Discussion/Possible Action on Evaluations: None presented on this date.

<u>Seat</u>: Markum stated that there was movement in filling this seat, but the board was searching for the Bylaws and will plan to present at the next Floodplain Meeting and then would present to the Commissioners. No action was taken.

<u>Board of County Commissioners, Payne County Oklahoma</u>: Markum stated that Jeremiah Gregory, legal counsel had reviewed the contract. Motion by Markum to approve the contract for sale of equipment as presented and for the Chairman to sign on behalf of the board, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – Road Name request BRUCE WAY for Keystone Engineering and Land Surveying:</u> Motion by Markum to approve the road name request and that no roads would be maintained by the County, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Purchase of Motor Graders for District 3 – between Armstrong Bank and the Board of County Commissioners, Payne County, Oklahoma</u>: Motion by Markum to approve the agreement with Armstrong Bank and to accept the interest rates and agreement pending the final approval of legal counsel, second by Reding. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Discussion/Possible Action – Road Closure Request – Lone Chimney Road from Highway 108 to Bethel – Saturday, September 9th, 2023 – Requested by the Glencoe Founders Day Committee: Cavett stated that the Committee would be notifying landowners of the times for the road closure for the 5K beginning at 6:55 am to 8:08 am. Motion by Reding to approve the request as presented, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.</u>

<u>Discussion/Possible Action – Authorization of the Payne County District Attorney's Office and/or assigned entity to handle the county's legal claims against H&G Paving Contractors Inc, Rich and Cartmill, Inc., and Argonaut Insurance Company in the public interest: Motion by Reding to allow the ADA to move forward on behalf of the county, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.</u>

<u>Discussion/Possible Action – ARPA Fund Grant Application Awards</u>: Cavett presented a list of applicants for the ARPA funds and would like to move forward with awarding a few of those today. Cavett stated the ARPA funds accrue about \$60,000 a month in interest. Cavett inquired on how those funds could be used with legal consultants Floyd & Driver. Cavett felt these entities have waited long enough to receive any of their funds. Reding inquired on Stillwater American Legion, Cavett and Markum stated they never saw them on the original list. Cavett stated if Reding can supply the application from their original submission they can always come back to that one.

Markum inquired about the employees receiving some of the funds for those that worked during the pandemic. Cavett's desire was to use the interest funds for now to begin awarding some of the applicants. Cavett also stated that in the near future when the subscriber issue is addressed for the radio system then they will know how much of the ARPA funds we will have available to use towards premium pay to employees who worked through the pandemic.

Reding inquired if the board had ever decided on standards for selecting the amount on which the employees would receive. Cavett stated in speaking with David Floyd with the law firm hired to oversee the expenditures of the ARPA funds his thought was to look at payroll and getting with offices. If an employee did not work during the pandemic at their office on location, then they are not eligible to receive it. Motion by Cavett to approve the list as presented with the use of the ARPA interest funds as follows; Our Daily Bread \$34,650; Love, Inc \$20,000; Glencoe, Ingalls Masonic Lodge \$8,000, Drug Court \$80,000, Expo Center \$150,000, Cushing Lions \$8500, Payne County Economic Development \$150,000, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.
