

Official Minutes of PAYNE COUNTY BOARD OF COUNTY COMMISSIONERS

The Payne County Board of County Commissioners met in a regular meeting of the board at 9:00 a.m. on **September 18th, 2023,** at the Payne County Administration Building, Gloria Hesser Commissioners Meeting Room 200/201, located in Stillwater, Oklahoma.

Chairman Zach Cavett called the meeting to order: Meeting called to order at 9:00 a.m.

<u>Discussion/Possible Action on Bid Openings – 9:30 AM</u>: None presented on this date.

<u>Discussion/Possible Action – ARPA Fund Grant Application Awards</u>: Reding would like to propose awarding American Legion 129 \$100,000 to repair water damage caused by drainage issues and replace flooring to keep upstairs a public rental and COCAA (Central OK Community Action Agency) for Payne County \$75,000 to purchase a small home in Stillwater to have as a permanent location for residents, to cut expenses and continue to provide assistance to the communities of Payne County. Motion by Cavett to approve the \$100,000 request for American Legion, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Motion by Cavett to table the request for COCAA to allow time to visit with Executive Director Tracey Izell, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Payne County</u>: Cavett stated this letter is stating our intent to participate in this program, bringing \$23 million into the state, which is due before our next meeting. Motion by Reding to approve the letter of intent to the Oklahoma Opioid Abatement Board with the chair to sign on behalf of the board, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

Discussion/Possible Action – Memorandum of Understanding for Naloxone & Fentanyl Test Strip Vending Machine to be placed on Payne County Property – between the Oklahoma Department of Mental Health and Substance Abuse Services and the Board of County Commissioners, Payne County, Oklahoma: Reding stated that the Sheriff had approached him about placing this in the lobby of the Courthouse. Reding felt this could be a great resource if someone has overdosed, there is no cost to the constituent nor the county for the vending machine or the materials. We would only supply the computer connection and power to operate; when the machine is low it notifies them, and they refill the machine. Motion by Reding to use the Courthouse Lobby for the vending machine, second by Markum. Roll Call Vote: Markum-Yes, Reding-Yes, Cavett-Yes.

<u>Payne County Health Department, Cushing between Stillwater Domestic Violence Services, Inc., dba Wings of Hope Family Crisis Services and the Board of County Commissioners, Payne County, Oklahoma:</u> Cavett stated that this is an agreement to supply a space for Wings of Hope until June 30, 2024.
