New Business/Discussion - no action will be taken:

JoAnn Swanson the new Payne County AT&T representative wanted to introduce herself to the board. JoAnne was assigned in January 2019 to Payne County. JoAnne apologized for the years that Payne County has been neglected in the area of customer service, and support, she is here to reach out and fix that. JoAnne talked about the many areas that are offered for service. Woodward also brought up the new first responder network. The board discussed this service, and who would be able to participate. The board members will be able to get this service as elected officials along with first responders, etc. JoAnne left her information. No action taken.

Announcement of Payne County Audits FY 2016-2017 & 2018: Marla Latham and Dorinda Gentry spoke to the board in regard to the upcoming audit and the fiscal years that they will be covering. Marla presented engagement letters to Chairman Chris Reding to have signed by him, Glenna Craig the County Clerk, and Carla Manning the Treasurer.

Disposal of derelict electronic equipment: Reding stated that the county will be having a third party come and remove old equipment to be recycled that has been junked or removed from inventory. All equipment needs to be on the third floor in piles for pelleting and preparing for pickup. Craig mentioned that this is equipment that has been removed on the property SA&I form from inventory. If you have equipment that needs to be junked, get the form to the Clerk's office to be approved in a Commission meeting. Craig also stated that if departments are going to have computer's etc. they need to have the hard drives removed. Woodward said that the Sheriff's Department can take the old hard drives and have them shredded with theirs. Bradford Cary with Beasley's will be organizing the equipment and doing the preparation for pickup. No date has been set at this time. Cavett also reminded everyone that the yearly spring auction held by Pickens Auction would be held at the end of the month if anyone wanted to place old equipment, etc. in the auction.

Request for possible use of sales tax funds for chiller replacement at the courthouse:

Reding stated that the chiller in the courthouse was going to need to be replaced soon. He stated it takes close to 6 weeks to get the chiller after ordered, plus the time needed for bidding. He wanted to get this replaced before summer. He is requesting the funds come from the general fund portion of the 3/8t cent sales tax. Craig asked if he had information on the cost. Reding stated close to \$100,000.00 he thought. Craig said she would like to see the bids, and the amount needed from this account before making this decision. Craig stated that this is also the account other large projects have been paid from, and that the county employee's vision and dental are paid from. The board requested Reding get bids, and bring back that information for a decision. No action taken
