

Terms and Conditions for Submitting Bids

1. Bids **MUST** be received in a sealed envelope by the date and time specified in the Invitation to Bid. Each envelope **MUST** be legibly marked on the outside with the following information: The word "BID", the Bid Number and the closing date. This information must be readily observable. Bid packets should be **returned to**: Payne County Purchasing Agent, Payne County Clerk's Office, 315 W. 6th, Suite 202, Stillwater, OK 74074; or brought to the Payne County Clerk's Office at the same address.
2. Sealed Bids will be opened by the authority requesting the bid, at the location and time specified in the published advertisement and on the "Invitation to Bid" form. **Late Bids will not be considered.**
3. Purchases by Payne County, Oklahoma, are not subject to State or Federal taxes.
4. Firm prices will be F.O.B. destination.
5. Unit prices will be guaranteed correct by the bidder
6. The Bid is submitted as a legal offer and any Bid when accepted by the County, constitutes a firm contract.
7. Oklahoma laws require each bidder submitting a bid to a county for goods, to furnish a notarized sworn, Affidavit for Filing with Competitive Bid (**Affidavit is included in this bid packet**).
8. This particular bid (**commonly referred to as "the six-month bid"**), establishes base pricing by unit of measure, valid for a 6-month period (**JANUARY 1 through JUNE 30**) on a variety of materials and services used in the construction and maintenance of the Payne County Road system.
9. Vendors may cite extraordinary circumstances adversely affecting the base price during the defined 6-month period in their bid submission. Vendor must define a specific condition that will trigger a price increase (example: fuel exceeds \$3.599 per gallon). Vendor must also identify the amount of the increase by percentage or by dollar amount for each submitted bid item when specified condition is met. Vendors must verbally notify the Payne County Purchasing Agent of the intended base price increase caused by the specified condition, before the new base pricing becomes effective. Written notification of the intended price change is required not later than the conclusion of the business week following the verbal notification.
10. The Board of County Commissioners, in conjunction with the Payne County Purchasing Agent will analyze all qualifying bid submissions. The lowest and or best bid will be determined based on the following considerations:
 - a. Price per unit of measure.
 - b. Distance and delivery time to the desired destination.
 - c. Product source (manufacturer, retailer, jobber).
 - d. Product availability.
 - e. Product quality.
 - f. Vendor's reliability.
 - g. Specific conditions identified by the Vendor triggering a base price increase.
 - h. Any additional consideration as may be deemed appropriate by the Board of County Commissioners.
