**Discussion/Possible Action Erroneous Assessments filed by Video Gaming Technologies, Inc. for 2019 taxes:** Kevin Ratliff attorney for Video Gaming Technologies presented to the board. Mr. Ratliff presented the appeal for 2019 taxes along with a recent supreme court ruling in regards to the Wagoner County Case which the board has been waiting on to determine if taxes are due in this situation as well as for prior years. The board was given an opinion by Lowell Barto, Payne County A.D.A. that the supreme court ruling should be adhered to, and no taxes assessed at this time. The board discussed with Mr. Ratliff the timing of the Wagoner County courts to appeal this decision with the U.S. Supreme Court, Mr. Ratliff said that would be 90 days from the ruling. The board is waiting on the official filing with the Wagoner County Courts, or to see if a U.S. Supreme Court filing is done in this case by Wagoner County. Motion to table the erroneous complaint filed by Video Gaming by Cowan, second by Bowen. Roll Call Vote: Cowan-Yes, Bowen-Yes, Wedel-Yes.

The board discussed the day and time of the next meeting to hear this tabled item along with any others filed after today's date. The board decided on January 21st at 11:00 a.m. in the Commission hearing room.
